For the past 10 years, the Columbia Flyway Show has been held at the Water Resources Education Center in Vancouver, Washington where it continued to grow in participation and entries. The last show in 2019, broke all attendance records. Due to the past two years of the Covid-19 virus, we were unable to book the Water Resources venue.

For the 2022 Show, we are moving to a spacious 15,000 s/f building owned by the Clatsop County Fairgrounds and Expo in historic Astoria, Oregon. The show focuses on hand-carved, textured, and painted wood sculptures of birds, fish, mammals, and North West Coastal Native American Carvings, in twenty competitive divisions.

View the judging of wildlife carvings in the main auditorium and the decoys in the water tank. Take advantage of the seminars and demonstrations. We have many World Champions and notable carvers presenting free seminars to help expand your carving knowledge.

There is a limited number of space to take a Friday all-day pay class with World Champion Carver, Tom Matus. Pre-registration is required. And as if that is not enough, join us at the water tank Sunday afternoon, for the Don Baiar Memorial 6" mini decoy floaters "trade" event where grown carvers get more excited than they should at the intense competition and nail-biting dramatics.

This show is a member of the International Wildfowl Carvers Association (IWCA). We will be hosting the "IWCA" Working Decoy Championship" open to all contestants, for 2022.

The Byrn Watson Memorial Award will be awarded to the "Best of Show" carving.

The Will Hayden Memorial Awards will be awarded to the Best of Show for intermediate and novice carvers. Due to the generous donations from area carving clubs and individuals who benefited from Will's years of friendship, mentoring, and support, this award will be given for years to come.

Also, being awarded is the Helen Foster Memorial Songbird Award.



"Carving & Painting Basics of a Canvasback Drake Head" With Tom Matus - World Champion

Join World Champion Tom Matus for a day of hands-on carving, painting, and learning the basics of decoy making. In the morning, the focus will be on carving a decoy head using key landmarks for bill detail & eye-setting. There is no expectation all participants will complete the carving and set the eyes during class.



The afternoon session will focus on painting basics including paint selection, brush selection, sealing the wood, blending paints, and then applying paint to a head silhouette. Acrylic paints will be available for use. Please bring brushes to apply paint.

A Canvasback head pattern, a tupelo head cutout, a set of eyes, and acrylic paint will be provided for a \$10 materials fee. A head pattern will also be placed on the website. You are welcome to bring your own wood head cutout.

Please bring a micro carver and/or a knife for use during the morning session. For the afternoon session, make sure you bring paintbrushes.

Preregistration is required. For questions contact Tom or Rick Pass. Cost: \$100 plus \$10 materials unless you bring your own head cutout, eyes, & paint. When your enrollment and payment have been received, you will be given a password to enter the Tom Matus Class materials page. This will include class updates, copyrighted patterns, and other information. CFWSA members receive a \$10 discount.

Saturday, October 1 - 9:00am-11:00am "Carving & Painting a Duck Bust"

With Brad Snodgrass, Master Carver

- Painting techniques, including sponging
- Finishing the project with conventional brushes
- Emphasis on air brush techniques & applications. Brad specializes in the "Full Decorative Style" of carving, where feather details are burned into the wood before painting. Few carvers these days have the time or patience to sculpt a full decorative bird. The technique is labor-intensive, and produces a bird that looks like it will fly away

"Color Theory & Methods" with a Master Carver & Painter Jerry Simchuk

- Painting with Acrylic Paints
- Paint mixing for desired colors
- Application methods and theory
- Brushes/tools for the desired result

People attending the class should be prepared to bring some paints, brushes, water container(s), and white paper/card stock to paint on. The instructor will have the participants work along to see how colors work together along with applying the discussed techniques to get a feel for these techniques and methods. Attendees should be prepared with questions they would like answered on the subject in the event they are not addressed during the main portion of the seminar.



- 1. Entries must have been made by the entrant and **never** before entered in this show (except for Gallery display items).
- 2. Entries must be carved of wood, cork, or stretched canvas. Metal or other materials can be used as a major support.
- 3. Components used to create the environment for decorative divisions must be entirely hand formed in the Open Level. Cast metal components are acceptable in the Intermediate/Novice level only.
- 4. Any visual identifying marks will be covered during the competition.
- 5. A deep brand with carvers name and date required on all Future Antique and Charles Bergman Antique entries.
- 6. Judges determinations are final and not subject to review.
- 7. The Show Chairman will have final authority on all show issues.
- 8. Carvers wishing to sell their entries must so indicate and specify the selling price on the entry tag. Checks should be made payable to the carver by the buyer. Carvings that have been sold may be picked up at the close of the show at 4pm on Sunday from the carver.
- 9. There will be Open, Intermediate, and Novice Levels in all Divisions except: Bench, Mini-Decoy Floater Trader, Charles Bergman Contest, Youth, Youth Silhouette, Artistic Carvings in Wood, Future Antiques, Interpretive, and IWCA Working Decoy Championship.
- 10. The Columbia Flyway Show and/or Clatsop County Fairgrounds cannot be held responsible for any loss or damage to artworks or personal items.
- 11. Your signature on the registration form indicates you have read and understand the show rules

Must be hand-carved wood. Transparent stain and texturing are allowed, but no paint. Glass eves are permitted. Entries may include wildfowl and mammals. All entries will be judged as one division. Open to all. Ribbons for 1st, 2nd, and 3rd Best of Division.

Division I. Waterfowl Bust New for 2022

The following are the carving rules for the Waterfowl Bust Purchase Award Contest. There is only one waterfowl bust contest. Carving will be a bust of any species of waterfowl. The bust will be life-size, include a head, bill, and shoulders with a flat base. The base may be part of the carving or removable. Carving is "Not" to be mounted on a dowel. Entries must be made of wood. There are no restrictions on carving, texturing, or painting. This is a Purchase Award Only with \$400 to the winning carver. Second, and third place will donate entries to the Saturday night live Banquet Auction and receive a 60/40 split of the sale price (carver gets 60%). All remaining carvers may choose to donate their entries to the Sunday silent auction and receive a 60/40 split (carver gets 60%).

Division J. Mammals

There will be no restrictions on the size of the carving. All texturing techniques are acceptable and no restrictions on painting. Any form of base may be used for support or display. Best of Division Open: 1st \$100, 2nd \$75, 3rd \$50.

Fish carvings must be of wood as the major material. Glass, plastic, or formed eyes may be used. Metal may be used for whiskers, barbells, fin trailers, and where strength is needed. Rough-outs, plastic plants, real rocks, plastic fins/tails/gills, may not be used. Entries for Miniature Division must be one-half size or less and must be 8 inches or less in every dimension for the fish. Bring what you carve or burn best! Ribbons for 1st, 2nd, and 3rd Best of Division

Division Q. Feathers

Feather must be carved of wood. Can be a feather of any species. Quill, shaft, and down can be painted to emulate the feather you are presenting. Ribbons: Best of Division Open, Intermediate & Novice

Division Y. Youth

Open to all carvers 17 years and under. Age is determined by how old the youth is on September 30, 2022. No entry fee.

YWF1 15-17 years of age Wildfowl or Fish YWF2 14 and under Wildfowl or Fish

Awards: ribbons

Division YS. Youth Silhouette New for 2022

Open to all carvers 17 years and under. Age is determined by how old the youth is on September 30, 2022. No entry fee. Carving will be an Atlantic Puffin Silhouette. Entries made of wood 1" thick or less (maximum from 11" from top of head to the tip of the tail). Edges may be rounded, wing, and bill definition is permitted. Glass eyes are permitted. 
Originals can be found in private and museum collections and various auction venues. Photographic renditions can be found on numerous websites.

Division C. Decorative Miniature - IWCA

The subject must be made of wood. Maximum subject size must be one-half life-size or less, not to exceed eight inches from the tip of the bill to the tip of the tail, along the length of the spine. Entries must be full-bodied except when part of an environmental composition. Ribbons: Best of Division Open, Intermediate & Novice

Division CBD. "Honoring Our Past" Charles Bergman Green-winged Teal Hen

Carve a replica of a Charles Bergman full-size Green-winged Teal Hen. Carvings may be finished by traditional painting or using antiquing methods. Entries will not be floated. Open to all Carvers. A basic pattern is found on the Columbia Flyway Wildlife Show website. Carver's name and year of completion are required on each entry. Entries lacking this information will not be eligible. Winners receive cash awards for Best of Division: 1st \$100, 2nd \$75, 3rd \$50.

Competition Divisions Continued D - G

Division D. Style Decoys - IWCA

Can be made of wood, canvas, or cork. Texturing by other than burning is OK. Carving on Crests is OK. Undercut primaries, scapular, and necks must not be fragile. Feather groups may be carved. Only primaries, tertials, scapulars & tail feathers may be individually carved. Feather splits & bill detail may be carved. Inserts may be used for strength & open bills are allowed. 2022 Featured Artist - Jim Bergeron

I grew up on a small farm in north-central Minnesota in the inside of the curve of a question mark made by the upper Mississippi River. It is a land of lakes, streams, and swamps. It was lived on by many Native American tribes, most recently by the woodland Sioux and now by the Chippewa.



A large percentage of the students where I attended high school were Native American It was not unusual

to hear Chippewa spoken on the sidewalks of Cass Lake. There were stories of former Indian villages, mounds, and finds of artifacts along the shores of the rivers and lakes near where I grew up. As I listened to the stories and read histories I became fascinated with the technology used by primitive people to live off the land. I soon learned to make stone tools.

After finishing graduate school in Oregon I went to work in Astoria, Oregon at the mouth of the Columbia River and home of the Chinook Indians. These people were magnificent woodworkers, often using woods that we do not use today and in ways that have almost been lost. I began teaching this art for many years and made the acquaintance of many area carvers and completed projects including masks, totem poles, bentwood boxes, drums, bowls, and various tools. My library now contains more than 250 books and pamphlets on Northwest Coast Indians.

While working at OSU I taught basic woodcarving, Northwest Coast style; bentwood box making; Adze and crooked knife making; and design. I have also taught the construction of various Indian fishing gears using Hilary Stewart's book "Indian Fishing". I have recently been doing classes at The Sitka Center, a non-profit art and environmental center on the central Oregon Coast. During the winter of 2003, a number of pieces were finished in the Chinook style for the Clatsop County Historical Society.
